PLANT SCIENCE California is increasingly impacted by fire, climate change, and the growing biodiversity crisis. The CNPS Plant Science Division makes important discoveries and much-needed advances to find solutions to these challenges. Under a cooperative agreement with the US Forest Service, CNPS provided scientific information regarding 224 Species of Conservation Concern that occur in six northern forests (Klamath, Lassen, Mendocino, Modoc, Shasta-Trinity, and Six Rivers National Forests). More than 200 volunteers participated in 70 Rare Plant Treasure Hunts to confirm plant occurrences and find new ones. Seeds from 10 rare plant species were collected, once they are cleaned and counted, the seeds will be deposited in an approved seed bank for permanent preservation. CNPS is working actively with local, state and federal partners to sample and monitor vegetation, develop vegetation classifications, and produce fine-scale maps across various areas of the state. This year, CNPS was involved in many survey and mapping projects such as Point Arena - Stornetta Unit of the California Coast National Monument, Whitebark pine (*Pinus albicaulis*) habitats across the national forests of California, and Owens Valley in the northern Mojave Desert.

Form 990, Part III, Line 4b:

MEMBER SUPPORTAs CNPS grows and has greater impact, our incredibly committed volunteers remain the most important part. We support 1,000 volunteers annually in 35 chapters serving all of California and Baja California, who contribute in excess of 90,000 hours. CNPS administration supports volunteers as well as staff, and thus administration costs are incredibly low when you include the ~46 additional positions represented by just our most skilled volunteers. These groups bring the CNPS mission to life in our communities by hosting native plant garden tours and field trips, operating nurseries and plant sales, conducting botanical surveys, and advancing local conservation action. They provide consultation to watershed and education groups in their communities and give educational talks up and down the state. The amazing volunteers gave their time at local nurseries, schools, and community groups to improve nursery practices, start public gardens, help their neighbors convert water-hungry lawns to natural landscapes, and more. CNPS chapter volunteers also served a critical need in their communities by helping to remove invasive species and restore landscapes at local and regional parks. DONATION AND BEQUESTS that support CNPS make it possible to grow and nurture a community of engaged Californians that continue, after 52 years, to be one of the greatest forces for positive change and thoughtful stewardship in the Golden State.

Form 990, Part III, Line 4c:

CONSERVATIONCNPS Conservation is the leading voice for protection of Californias incredible and imperiled botanical biodiversity. Hundreds of volunteers accomplished inspiring successes via advocacy, education, legislation, and as a last resort through litigation. After a year of working with former Gov. Brown and a group of scientists, CNPS helped draft the CALIFORNIA BIODIVERSITY INITIATIVE, which is a short report outlining a "roadmap" for how California can maximize the preservation of our extremely diverse biodiversity through planning, management, and monitoring over the next few decades. The Roadmap specifically mentions several CNPS efforts: Important Plant Areas, seed banking, Rare Plant Treasure Hunts, and vegetation mapping. Fortunately, the Newsom administration has maintained momentum in the Biodiversity Initiative, and CNPS is working closely with state agencies tasked to implement the Roadmap. CNPS is promoting more aggressive state goals for carbon sequestration to tackle CLIMATE CHANGE to make sure loss of biodiversity is not an unintended consequence of taking bolder action. CNPS is providing input to some of the proposed interventions on forests, grasslands, wetlands, agricultural lands, and urban forests. With WILDFIRE on the minds of many, CNPS is part of multi-stakeholder working groups to establish adequate monitoring and adaptive management processes to track on-going effects of timber regulations. In southern California, CNPS chapters are mobilizing to speak out against harmful sprawl development on Tejon Ranch and the southern border of Joshua Tree National Park. We are participating in environmental review of 3 proposed desert solar projects: Crimson Solar, Desert Quartzite Solar, and Palen Solar. Our project to map all of Californias Important Plant Areas (IPAs) is moving ahead after expert workshops in five regions. We are compiling our collected data into a conservation value model, which will result in a statewide map that highlights the IPAs that need to be conserved.
