TEAM IS A NOT-FOR-PROFIT CORPORATION AND THE FEDERALLY-DESIGNATED ANTIPOVERTY AGENCY SERVING SOUTHWEST/CENTRAL CONNECTICUT AROUND THE NAUGATUCK RIVER VALLEY AND SURROUNDING REGION. PRESIDENT LYNDON JOHNSON'S SIGNING OF THE ECONOMIC OPPORTUNITY ACT OF 1964 PROVIDED THE FOUNDATION FOR THE CREATION OF TEAM - THIS ACT LAID THE GROUNDWORK FOR THE CREATION OF COMMUNITY ACTION AGENCIES, HEAD START, LEGAL SERVICES, AND MANY OTHER INITIATIVES TO COMPREHENSIVELY ADDRESS THE COMPLEX NEEDS OF THE POOR AND TO ELIMINATE THE CYCLE OF POVERTY. IN PRESIDENT JOHNSON'S ANNOUNCEMENT OF PROJECT HEAD START, HE SPOKE TO THE IMPORTANCE OF INVESTING IN CHILDREN - 50% OF THOSE IN POVERTY WERE CHILDREN. TODAY, TEAM REMAINS TRUE IN ITS MULTIGENERATIONAL SERVICE DELIVERY SYSTEM FOCUSED ON SUPPORT SERVICES, EARLY CHILDHOOD, AND ELDERLY SERVICES.
