

Election Under Treasury Regulation Section 53.4942(a)-3(c)(2)(iv)

Harbourton Foundation (“Harbourton”) made a grant of \$500,000 in cash to Piper Sutton Foundation, Inc. (“Piper Sutton”) on April 29, 2019 (the “Grant”). Harbourton notified Piper Sutton that Harbourton intended to report the Grant as a “qualifying distribution” within the meaning of section 4942(g)(3) of the Internal Revenue Code (the “Code”) for Harbourton’s taxable year ending December 31, 2019.

In order to satisfy the requirements of Code section 4942(g)(3) and Treasury Regulations section 53.4942(a)-3(c) in connection with the Grant, Piper Sutton hereby elects pursuant to Treasury Regulations section 53.4942(a)-3(c)(2)(iv) to treat as current distributions out of corpus the minimum amount necessary to satisfy such requirements with respect to the Grant. Specifically, subject to any future adjustment as described in the following paragraph, Piper Sutton hereby elects to treat as current distributions out of corpus:

- (i) \$493,527 of its excess qualifying distributions carryover from its taxable year ending April 30, 2014, as listed on line 3a of Part XIII (i.e., the entirety of that \$494,697 excess qualifying distributions carryover, less the portion of that carryover applied to Piper Sutton’s distributable amount for its tax year ending April 30, 2019, which was \$1,170) and
- (ii) \$6,473 of its excess qualifying distributions carryover from its taxable year ending April 30, 2017, as listed on line 3d of Part XIII.

Piper Sutton believes that the amount covered by this election is \$500,000, comprised as described above of excess qualifying distributions carryovers from its taxable years ending on April 30 of 2014 and 2017. However, if it is later determined that a different amount is the minimum amount necessary to satisfy the requirements of Code section 4942(g)(3) and Treasury Regulations section 53.4942(a)-3(c) with respect to the Grant, then this election shall cover such different amount, and such amount shall be comprised of Piper Sutton’s excess qualifying distributions carryovers (if any) from its taxable years ending on April 30 of 2014, 2015, 2016, 2017, and 2018, in that order.


In accordance with Treasury Regulations section 53.4942(a)-3(c)(2)(iv), Piper Sutton confirms that the above-described \$500,000 of excess qualifying distributions carryovers from Piper Sutton’s taxable years ending on April 30 of 2014 and 2017, or, if different, those qualifying distributions carryovers that are later determined to be covered by this election pursuant to the preceding paragraph, (i) were treated under Treasury Regulations section 53.4942(a)-3(d)(1)(iii) as distributions out of corpus for such years; (ii) have not been availed of by Piper Sutton for any other purpose; (iii) occurred within the preceding 5 years of Piper Sutton’s taxable year ending April 30, 2019; and (iv) will not later be availed of by Piper Sutton for any other purpose.
