Computers are then cleaned, processed through a stringent quality check, and installed with a new operating system.

Distribute. Affordable high-quality computers are distributed to income qualified individuals through our retail stores, online, and through national distribution events.

Support. Once a customer has received their computers, it is important that they are confident in their purchase and feel supported. Each computer comes with a 1-year hardware warranty, free digital literacy training, and phone support.
