Support provided toward the operation and maintenance of a home for dependent aged members known as Moosehaven, Inc. Moosehaven is a retirement community that is available to qualified Moose members and their spouses who have a need to go there for their retirement years. Moosehaven, Inc. assumes full responsibility for total care of residents, including providing food, clothing, housing, and medical and dental care. Moosehaven also benefits the community by aiding in extending the lives of residents and enabling them to live safe, useful and independent lives and to relieve stress. The approximate number of members served is 300.
