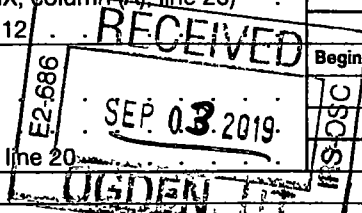

Every year a different chapter within the ICAK hosts our annual meeting. In June of 2018 our annual meeting was hosted by the UK chapter and held in Edinburgh. The bulk of the funds in support of this meeting were sent via PayPal in 2017 and included in the 2017 filing. A small amount, the remainder of the funds needed to cover the cost of IC members attending the meeting (\$450 per attendee) was paid in 2018 but not included in Schedule F as it was well under \$5,000 (\$1,851).

The 2019 annual meeting was held in March and thus, within the 2018 fiscal year. It was hosted by the Australasian chapter and held in Brisbane, Queensland, Australia. The grant from ICAK, Inc to the Australasia chapter in support of the cost of hosting the meeting was \$8,320 and was wired to the chapter's bank after the meeting. Again, the grant is based on the number of IC members attending at a set amount of \$450 per attendee.

At our annual meetings, exams, monitored by the IBE, are held on the first day along with the IC (International Council) meeting and meetings of the different boards, the IBE, IBORS and IEC. On the second, third and fourth days a congress is held with paper presentations from practitioners from around the world. Both the Edinburgh and Brisbane meetings were great successes.

Part III, 4a & b: One could argue the primary service the ICAK provides is the DIBAK (Diplomate in Applied Kinesiology). Initially exams are set to determine proficiency in AK by all its members and later, for those members so inclined and who meet the requirements, to become certified teachers. The importance of this examination process is at first, to promote a high level of skill and understanding of AK theory and technique, designated by the post-nominal letters, DIBAK. Only DIBAK's can become certified teachers and only hours taught by a DIBAK (300 hours) can qualify towards sitting for the examination. At an arm's length from the IC is the IBE, a board within the ICAK, which designs exams questions, organizes exams held at annual IC and chapter meetings and invigilate and grade exams. The IEC, another board within ICAK, oversees the recertification of teachers, the standardization of the ICAK teaching syllabus and the creation of new teaching modules. Both the IBE and the IEC maintain their own treasuries and submit financial reports, included in this filing. IBORS, a third board within the ICAK, oversees research and the standardization of AK technique.

Part VI, 11b: The ICAK treasurer, who completes this filing, distributes a PDF copy to the IC executive and if timely, brings a hard copy to the annual meeting for review prior to mailing to the IRS. The was done with the 2017 filing in at the Edinburgh meeting in June of 2018.

Each year the ICAK holds and annual meeting with scientific conference, hosted by different chapters who, have submitted a proposal with budget for IC review and vote, at least 2 years prior to proposed date. In 2018 the meeting was in Edinburgh, in 2019 in Brisbane (Part III, 4a and schedule I) and in 2020 and 2021 will be in Bruges, Belgium and Montreal, Canada respectively.
