A committee is selected by the Class I Directors to manage the grant application and monitoring process. In the application phase, the monitoring committee reviews the applications, meets with potential grantees, verifies the applicants are 501c3 organizations, and compiles the list of potential grant recipients for the Canale

Foundation directors. The monitoring committee is then charged with overseeing the project status for the duration of the grant period. To assist with this ongoing review, the grant recipient is required to submit a written narrative and financial report of the project status to the monitoring committee on either a semi-annual or annual basis, depending upon the length of the project. All grantees are required to submit a final report to the monitoring committee upon completion of the grant period.
