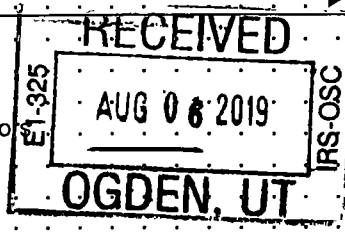

Due to Stage IV Prostate Cancer for the last three years, the income and the outreach of the 501(c)(3) Public Charity has been greatly affected. The only income for the ministry is the 12,000 in social security benefits, \$2,400 in a donation of the rent on the home office due to owner Marcy Mann states of changing the property into homestead exemption. Her income was disguised by giving her a salary of 1200 last year.

The other major factor in expenses due to the treatment of the Prostate Cancer comes from the social security payments and the need to pay doctor and hospital bills that the social security medicare does not cover. For 2018 this sum is estimated at \$1,500.00
