**Central Park Ice provided skilled coaching from ten professional figure skating coaches with credentials in synchronized ice skating to 59 boys and girls ranging in age from 7 to 18 at weekly practice sessions two to three times per week. Practices included on-ice and off-ice training, conditioning and ice times and an off-site summer boot camp and one weekend intensive training.**
