To ease the burden of buying back-to-school supplies, CCA provided 63 fully packed bags of age-specific school necessities for seriously ill children and their siblings.

The impact of our talented staff was multiplied by over 3,340 generous volunteers who invested 13,949 hours into our local community. The monetary value of this volunteer time is nearly \$355,000.

This year, CCA's education and resources were accessed over 1,330 times by families, caregivers, and volunteers.

A Chemo Pal mentor can also give parents a much-needed break to grab a cup of coffee, talk with doctors, or spend time with their other children.

CCA Chemo Pal mentors are carefully screened, trained, and thoughtfully matched with families, including those with bilingual needs. Chemo Pal mentors and kids spend about four hours per month together, both in hospital and out in the community, enjoying activities like sporting events, concerts, and craft and gaming nights. The average match lasts 12 months, and many last for the duration of a child's treatment. CCA provides ongoing support and education for our front-line volunteers.

This year, CCA delivered the joy of friendship to 190 Pacific Northwest children and teens. In addition, we provided 2,830 events, activities, and tickets to kids, family members, and their Chemo Pal mentors outside of the hospital environment.

NatureRx - CCA's NatureRx programming includes stays at The Alexandra Ellis Caring Cabin, providing children and teens who are in treatment, along with their families, an extraordinary place to retreat, relax, and create once-in-a-lifetime memories outside of the hospital environment.

Nestled in 24 acres of surrounding woods with plentiful wildlife and a serene lake, the Caring Cabin provides an essential health connection to nature and healing.

Between 35 and 40 friends and family members visit CCA's luxurious Caring Cabin hideaway in a typical month. This free adventure helps restore the energy and hope kids need to battle their illness over the long haul. This year, the Caring Cabin hosted 39 families.

To fill a gap in servicing the specific needs of teens and young adults in our community, this year our NatureRx program also offered nine immersive outdoor adventures, including hiking, kayaking, photography, and yoga designed specifically for teens and young adults. These Joy-based nature experiences for teens provide needed peer connection and are designed to enhance their emotional well-being.
