The mission of the Maine Jewish Film Festival is to enrich, educate and entertain a diverse audience through the presentation of film programs based on the global Jewish experience. Programs often include post-film speakers and discussions. Our primary event is the film festival held in March. This festival lasts approximately 8 days, with programs in Portland, Brunswick, Lewiston, Waterville, Bangor and Rockland. Approximately 3000 film goers attend. In addition to the film festival in March, the organization also organizes various film events in the fall and spring and works with schools to present festival films in educational environments.
