All recipients in Vietnam are visited before they receive support to ensure that they meet the program criteria. After support is received the Executive Director makes a return visit to ensure that the promised support was given by the program partners. Recipients sign an invoice that outlines the type of support they received. In Laos, the Executive Director, visits as many of the beneficiaries of medical assistance/vocational training as possible. If the ED is unable to visit them individually the Lao staff sends photographs of the beneficiaries before and after their support and send detailed receipts of any expenses incurred. Beneficiaries sign a receipt that they have received any advanced funds for travel and produce receipts for the travel and meal expenses to/from their home for medical and vocational services.
