Provide post-secondary education leading to a baccalaureate degree. Program service expenditures are made in conjunction with the operation of a liberal arts college spread over 107 acres with approximately 63 educational and support buildings. The College is accredited by the North Central Association of Schools, and had 1,524 full time equivalent students in the undergraduate level with 127 full time faculty. Bachelor of Arts degrees conferred were 356 during the year, with 10 Master's degrees conferred. The College had approximately 1,100 resident students in the residence halls.

The College has determined that its tax provisions satisfy the more likely than not criterion and that no provision for income taxes is required at May 31, 2019.

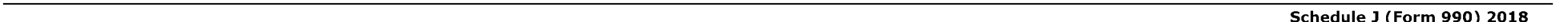
