A student's standing was determined independently in each program. Black American students could qualify for recognition and be honored as Scholars in both the National Merit Program and the National Achievement Program, but could receive only one monetary award from NMSC. For fiscal year 05/31/19 the National Achievement Scholarship Program included Four-Year Renewable Scholarships 73 recipients.
