The merchandise is never sold and must be used for the care of or use of the poor, the ill, the elderly or children. The majority of the merchandise is valued at an estimated retail value.

Most donating corporations provide NewThreads with a valuation of the merchandise they contributed (typically with the retail value or some other modified cost valuation). When no valuations are provided by the donor (which rarely happens), NewThreads estimates the retail value by comparing the merchandise donated to other similar merchandise being sold in retail stores or through on-line retailers.
