A FINANCIAL INTEREST EXISTS IF THE MEMBER OR FAMILY MEMBER HAS OWNERSHIP OR INVESTMENT INTEREST IN ANY ENTITY WITH WHICH JSL HAS A TRANSACTION OR ARRANGEMENT, OR A COMPENSATION ARRANGEMENT WITH ANY ENTITY OR INDIVIDUAL WITH WHICH JSL HAS A TRANSACTION OR ARRANGEMENT, OR OWNERSHIP OR INVESTMENT INTEREST IN, OR COMPENSATION ARRANGEMENT WITH, ANY ENTITY OR INDIVIDUAL WITH WHICH JSL IS CONSIDERING ENTERING INTO A TRANSACTION OR ARRANGEMENT. 2. WHERE A JSL MEMBER OR FAMILY MEMBER HAS A NON-FINANCIAL INTEREST IN A JSL DECISION OR MATTER. EXAMPLES OF SUCH AN INTEREST INCLUDE, BUT ARE NOT LIMITED TO, UNPAID SERVICE ON THE BOARD OF DIRECTORS OF A NON-PROFIT ORGANIZATION SEEKING JSL FUNDING OR OTHER SIGNIFICANT VOLUNTEER ACTIVITY ON BEHALF OF SUCH AN ORGANIZATION.
