CPLS provided a hot lunch program for its students and faculty,
designed to offer nutritionally adequate, appealing, and affordable

34 students received hot lunch assistance during the 2018-2019 school
year. Families who qualify for tuition assistance are also qualified
for reduced lunch prices for their children based on a sliding scale.

CPLS provided inter-scholastic athletic programs to its middle and
upper school students in seven sports, with the goal of promoting both
