Criteria for scholarship eligibility are 1) must be a Fort Bend County resident and 2) the student must be in good academic standing. Our organization previously contributed \$25,000 to another Texas A&M University endowed scholarship fund. That scholarship is fully funded and annually awards a scholarship which will continue in perpetuity.
