The University comprises two schools: the College of Social Sciences, which offers degrees in Humanistic and Clinical Psychology, Counseling (M A), Leadership and Management (M A and Ph D in Organizational Systems and M A in Management), and Transformative Social Change (M A and Ph D), and the College of Integrative Medicine and Health Sciences, which offers degrees in Mind-Body Medicine (M A and Ph D) and Integrative and Functional Nutrition (M S). The University also offers certificates, continuing education, and professional studies in several of these areas. The learning model includes online-hybrid and residential formats. Saybrook served over 800 students during the fiscal year ended May 31, 2019.

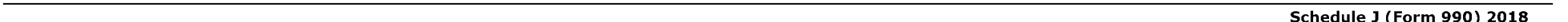
