An estimate of the total value of objects acquired by gift in years prior to 1997 is not readily determinable. The total value of gifts received since 1997 is \$14,778,745. The total value of objects purchased from December 31, 1997 through June 30, 2019 and 2018 was \$31,301,446 and \$28,652,860, respectively. For the years ended June 30, 2019 and 2018, the Museum sold deaccessioned collections and objects of art totaling \$71,377 and \$370,715, respectively. The selling price of these items approximated their fair value.
