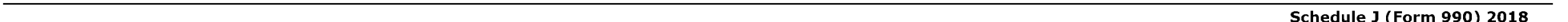

Eligible employees hired prior to July 1, 2006 are grandfathered under the Plan and will continue to accrue benefits as long as they remain at a participating System entity and in an eligible status. The System's funding policy is to contribute amounts to the Plan sufficient to meet minimum funding requirements set forth in the Employee Retirement Income Security Act of 1974, plus such additional amounts as might be determined to be appropriate from time to time. The Plan is intended to constitute a plan described in Section 414(k) of the Internal Revenue Code, under which benefits derived from employer contributions are based on the separate account balances of participants in addition to the defined benefits under the Plan. Douglas F. Dean, an officer of the filing organization, resigned from his position with the Hospital in calendar year 2018. Historically, Dean received defined contributions under the 414(K) plan, due to being grandfathered into the pension system. However, in calendar year 2018, neither Dean nor any other officers or employees of Elliot Hospital received defined contributions under the now-closed 414(K) plan. Additionally, defined benefit amounts for Holly Mintz of \$27,659 are included in Schedule J, Part II, Column C and Form 990, Part VII-A, Column F as deferred compensation.

The LLC is unrelated to the filing organization and its affiliates. The total compensation paid to Mr. Ingold's LLC for his services during 2018 was \$310,944. Additionally, Mr. Ingold received a housing allowance in the amount of \$12,500 during the 2018 calendar year, which is included in the amount paid to Ingold & Associates, LLC. As the fees paid to the LLC were paid for services to the entire related party system, an accurate breakdown of the fees relative to the filing organization is not readily determinable. In accordance with IRS instructions, these fees have been reported as compensation on Form 990, Part VII-A and Schedule J, Part II and further disclosed in Schedule O for Form 990, Part VI, Line 3.
