THE ORGANIZATION DOES PROVIDE THE LATTER FOR CONGREGATIONS WHEN SPECIAL CIRCUMSTANCES WARRANT, AS IN THE CASE OF A CATASTROPHIC EVENT THAT HAS DESTROYED CHURCH PROPERTY AND THE CHURCH IS FINANCIALLY UNABLE TO REPLACE PEW BIBLES THEMSELVES. PREFERENCE IS GIVEN TO OUTREACH PROJECTS WITH AN ONGOING LEADER/TEACHER PRESENCE.
