ELM IS COMMITTED TO COMBATING CLIMATE CHANGE AND PROTECTING OUR LAND, WATER, AND PUBLIC HEALTH. BY CREATING DIVERSE ALLIANCES AND BUILDING THE POWER OF THE ENVIRONMENTAL COMMUNITY, ELM USES ITS COLLECTIVE INFLUENCE TO ENSURE MASSACHUSETTS IS A LEADER IN ENVIRONMENTAL AND ECONOMIC SUSTAINABILITY.ELM HAS LONG BEEN A CORNERSTONE OF THE ENVIRONMENTAL COMMUNITY IN MASSACHUSETTS. ELM'S EARLY WORK INCLUDED THE PROMOTION OF SUSTAINABLE FORESTRY PRACTICES STATEWIDE AND VIGOROUS PROTECTION OF MOUNT GREYLOCK (AN EFFORT THAT CONTINUED - WITH GREAT SUCCESS - FOR MORE THAN 75 YEARS, AND INCLUDED THE ESTABLISHMENT OF MOUNT GREYLOCK AS MASSACHUSETTS'S FIRST STATE PARK). GREEN BUDGET: SEVERE CUTS TO ENVIRONMENTAL AGENCY BUDGETS AND STAFF REDUCTIONS ARE PREVENTING MASSACHUSETTS FROM LIVING UP TO ITS POTENTIAL.
