The License Plate Program grants funds received from sales of the "I'm Animal Friendly" license plate to non-profit humane organizations and municipal animal control agencies in the Commonwealth that provide spaying and neutering services for cats, dogs and rabbits. In this year's grant cycle, 25 organizations representing 28 projects received funding. These projects benefit the community, the Commonwealth and of course, the animals. Since the programs inception in 2004 over 2.4 million dollars has been granted, enabling tens of thousands of animals to receive services that both improve their health and reduce the population of unwanted pets.

These sessions are not only educational but they enable networking amongst the participants, and are integral to MAC's mission to create forums for dialogue and strategic collaboration to reduce the number of homeless, neglected, displaced and abused companion animals.

The AniMatch program assists animal welfare organizations across the state in transferring cats and dogs that are in need of placement from organizations in the state. The AniMatch program assists animal welfare organizations with limited resources to those that have a better ability to find the pets a "forever home". Over 3,000 dogs and 224 cats have been assisted since the programs inception.
