

In the 2018-19 academic year, New Hope Tutorials offered 25 full-year courses to a total of 102 students from 72 families in six core subjects. 19 of our students graduated in spring of 2019, most of them went on to four year colleges. New Hope Tutorials also provided Short Courses and several workshops, running six to ten weeks, along with outside activities to enhance classroom learning (such as field trips, labs held at nearby Gordon College, and the like.)
