The organization's main program consists of various efforts to reduce the harm caused by smoking and tobacco use on the citizens of South Carolina. These efforts during the fiscal year included education and participation in the Point-of-Sale statewide project through cohorts. In addition, the organization underwent a significant operational overhaul due to the transition to a new Executive Director. This overhaul included a name change and rebranding, website redesign, bylaws update and efforts to streamline board communications and meetings while enhancing board engagement. Education efforts for the fiscal year included the Annual Smokefree SC Summit with record attendance of 140 health care professionals from SC and NC. The Summit topic focused on the emerging public health crisis of Youth Vaping, and conference presenters included speakers from two national organizations dedicated to reducing smoking and tobacco use throughout the U S as well as highly regarded public health researchers whose work focuses on tobacco control.
