

**Green Infrastructure Coalition:** Received one grant this year \$75000 from the RI Foundation. Total spending \$81118

Spending included spending from previous FY grants from RIF and Van Beuren Charitable Foundation. About half the funds are sent to members of the coalition to cover staff time for meetings and projects. The rest was spent on projects including rainwater systems, trainings for designers and landscapers. This project continues.

Energize coalition. This project received one grant of \$45000 from the Merck Foundation. It spent \$15998. Funding went to support the participating partners in their work of educating Rhode Islanders about the benefits of a carbon tax system. Due to organizational issues the project took a hiatus, but has since reorganized and will spend down its grant this year and then close.

RI School Recycling Club. Received two grants, one from the RI Foundation of \$10000 to make a video about RI state parks. This grant was all spent on the project. The other grant was through the RI Dept of Environmental Management for \$22500 to study how schools manage compostables in the lunchroom. It is ongoing. Total spending so far \$27500

Compost Initiative. ECRI Ed Fund puts on the annual RI Compost Conference and Trade Show. Conference took in from sponsors, exhibitors and ticket sales \$5736. Expenses were \$1871 for printing and food for attendees.

Tisdale Environmental Education Awards gives out 3 \$250 grants each year to RI schools or after school programs for environmental projects with student participation. Raffles of small donated prizes for all funding. Sold \$1075 worth of tickets. Expenses are grants we give out, licenses from the city and state to hold a non profit raffle, and printing raffle tickets. \$825 in total including the grants.

990 ez page 2 Part IV. Treasurer Ken Filarski is the sole proprietor of an architectural and planning firm and is a member of the Energize Coalition and the Green Infrastructure Coalition. He received payment of \$5000 for work done as part of the 2 coalitions, not for any work done for the ECRI Ed Fund.
