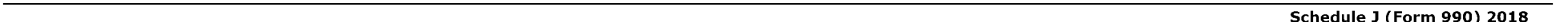

In 2017, a nationally recognized consultant was engaged to conduct a compensation analysis for the President, Vice President and Dean positions. Their analysis was submitted to the Chair of the Board of Trustees in September 2017. The same consultant aged the data for use in 2018 and 2019. There were several executive level transitions in 2018 and 2019, so the 2019 analysis also included additional executive positions. The basis of the analysis is detailed as follows: The firm based their analysis on market comparisons drawn from a blend of national and regional comparison groups that include highly ranked colleges and universities with comparably high admission requirements and from national and regional institutions that are comparable to Olin in terms of finances, academic programs, reputation and mission. General industry data was also included for those positions that are not unique to higher education. For each group, the consultant analyzed base salary, total cash compensation and total compensation for the 25th, 50th, 75th and 90th percentiles and adjusted the market data to reflect a common effective date of July 1, 2019. The Executive Committee of the Board of Trustees used this data to develop a recommendation for the President's compensation which was reviewed and approved by the full Board of Trustees. The President used this data to develop recommendations for the compensation of the Vice Presidents and Deans which were reviewed and approved by the Executive Committee. All decisions regarding compensation are approved by independent persons and all deliberations and decisions are substantiated contemporaneously.
