IT CARVES A SPACE FOR TRADITIONAL MUSIC TO INTERACT WITH AND REMAIN RELEVANT TO THE RAPIDLY CHANGING CONTEMPORARY SOCIAL CLIMATE, WHILE SIMULTANEOUSLY BUILDING AND STRENGTHENING A COMMUNITY OF ARTISTS, STORYTELLERS, PERFORMERS, LISTENERS, EMPLOYEES AND VOLUNTEERS. JALOPY THEATRE FEATURES LIVE MUSIC 6 NIGHTS EACH WEEK, PRESENTS 7 DIFFERENT ANNUAL FESTIVALS BOTH AT JALOPY AND AROUND THE CITY, PROVIDES MUSIC ENRICHMENT PROGRAMS IN LOCAL SCHOOLS, OFFERS DOZENS OF WEEKLY IN-HOUSE PRIVATE AND GROUP CLASSES FOR ADULTS AND CHILDREN IN VARIOUS MUSICAL STYLES, CURATES RECURRING MONTHLY AND ONE OFF WORKSHOPS LED BY LOCAL AND TRAVELING MUSICIANS, AND HOSTS MULTIPLE FREE AND INCLUSIVE JAMS AND SONG CIRCLES. MOREOVER, THE THEATRE RUNS ITS OWN IN-HOUSE RECORD LABEL, JALOPY RECORDS, WHICH ISSUES MULTIPLE RECORDINGS EACH YEAR, FEATURING THE MUSIC OF CONTEMPORARY ARTISTS AS WELL AS HISTORICAL RECORDINGS. JALOPY PARTNERS WITH THE MAYRENT INSTITUTE OF YIDDISH CULTURE TO DIGITIZE YIDDISH RECORDINGS FOR FREE PUBLIC ACCESS. JALOPY'S REORGANIZATION AS A NONPROFIT ENTITY IN 2017 FURTHER STRENGTHENS ITS ABILITY TO PURSUE AND REALIZE THIS MISSION, ONE THAT IT HAS UNCOMPROMISINGLY FOLLOWED SINCE OPENING ITS DOORS TO THE PUBLIC. DURING THIS FISCAL YEAR, JALOPY PROVIDED MUSIC EDUCATION TO 886 ADULTS AND 105 CHILDREN. AN ADDITIONAL 100 NEW YORK PUBLIC SCHOOL CHILDREN WERE SERVED THROUGH THE COMMUNITY THROUGH MUSIC PROGRAM. IN-HOUSE CONCERTS WERE ATTENDED BY 8,000 PEOPLE, AND 3,700 ATTENDED JALOPY FESTIVALS. OVER 1,000 BANDS PERFORMED AT VARIOUS JALOPY SHOWS.
