These adjusting entries were made after we filed Form 990 (2017), and they are: (i) write-down of \$48,920 of pledges deemed uncollectible; (ii) accrual of \$129,925 of a program expense that was incurred but not recorded; and (iii) increase book value of a donated life estate by \$484,704 to fair market value.
