MUCH OF OUR ADVISORY WORK FOCUSES ON AIDING LOCAL STAKEHOLDERS IN THE DESIGN AND IMPLEMENTATION OF THEIR OWN PEACE AND DIALOGUE PROCESSES. INTEGRAL TO THESE EFFORTS, WE SEEK TO IMPROVE THE PRACTICE OF PEACEBUILDING MORE BROADLY THROUGH SHARED KNOWLEDGE RESULTING FROM DIALOGUE, RESEARCH, AND EDUCATION EFFORTS UNDERTAKEN WITH OUR NETWORK OF LOCAL AND INTERNATIONAL PAR TNERS.
