In the past tax year, the funds distributed from the Christine Carleton Charitable Trust have been applied to core facility maintenance and upgrades including: floor refinishing; door replacement; managers office refresh; electrical distribution upgrades; installation of new entrance signs to comply with FDNY regulatory requirements; installation of a new machine shop sink; high-bay lighting upgrade; information technology upgrades to facilitate transition to a paperless environment; repair and upgrade
