

Form 990, Part III, Line 4a - KidsCareEverywhere's mission is saving children's lives, by empowerment of physicians in under-resourced environments with multi-media, state-of-the-art medical software, and through inspiration of young professionals to become future global healthcare leaders. With software donated to us, KidsCareEverywhere works with local health leaders to provide cost effective, sustainable and reproducible interventions. KCE's primary program is to distribute medical software and to train doctors and medical professionals in their use in clinical practice. KCE is a 501(c)(3) public charity dedicated to transforming pediatric care in under resourced communities by enabling doctors and medical professionals to care for sick children more effectively and at lower cost. Further information can be found at our website at www.kidscareeverywhere.org. We do this by donating software called DynaMed Plus and training doctors and medical professionals in its use. This software supercedes PEMSoft, which is now incorporated into DynaMed Plus. This software is available primarily as a mobile application, resident on a smart phone. It is often installed on hospital servers, so that it is available to all hospital medical professionals, for daily use. Web based versions of the software are also available, and often times downloaded to laptops and desktop computers. DynaMed Plus is gifted to KCE by EBSCO Health, Ipswich, Ma. During the fiscal year 2018-2019, KCE Volunteer teams visited 4 different countries, and eight major hospitals. In Peru, the KCE team visited four hospitals and one medical school. The hospitals included Hospital Nacional Dos de Mayo, Hospital Nacional Cayetano Heredia, Instituto Nacional de Salud del Niño, Universidad Nacional Mayor de San Marcos, as well as one medical school, all in Lima Peru. The KCE team of two doctors and KCE's Program Director trained 410 physicians. In India, the KCC team conducted training and distributed DynaMed Plus to 4 hospitals and medical schools. They were University College of Medical Sciences (Delhi), Dayanand Medical College (Ludhiana), Hospital Government Medical College (Amritsar), and SRCC Children's Hospital (Mumbai). The KCE team consisted of 3 board members, program director, and another team member. This team trained 750 doctors and medical professionals. In Nepal, the KCE team conducted training and distributed DynaMed Plus to one major hospital, Patan Academy of Health Sciences, in Kathmandu. 92 doctors were trained in four sessions, and the KCE team offered remote training to various doctors who were unable to attend the hospital training. The KCE team consisted of 1 board member, KCE's Assistant Director, and 3 additional volunteers. Lastly, KCE collaborated with the Childrens Well Being Foundation (CWBF) in Costa Rica. Clinical training were held in San Jose, and 31 physicians were trained by KCE's team of 1 board member and one volunteer.
