These funds supported the daily education of over 300 children in the main school in Kabul as well as literacy training for children in IDP (internally displaced person) camps around the city. More than 2,000 children throughout the year benefit from outreach programs including vocational training, mobile libraries and recreational activities. The funds specifically paid for teacher salaries, daily hot meals, supplies, utilities and building maintenance.

Form 990, Part III, Line 4b:

These funds were used to provide stipends to the families of the children attending classes at the main center. Families rely on these children to earn money working on the streets; the stipends enable the children to attend school instead.

Form 990, Part III, Line 4c:

These funds supported satellite school sin Mazar-i-Sharif and Gardiz. More than 200 students are served between these locations. Funds pay for salaries, supplies, rental space and utilities.
