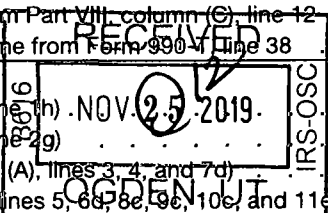

FIRST Tech Challenge - Over 180 teams participated in Illinois during the past year. The season included leagues, meets and qualifying tournaments and an Illinois state wide championship. Approximately 1600 students were involved in the program.

FIRST Robotics Competition. The FIRST Robotics Competition activity in Illinois is run by FIRST (5013c in New Hampshire). Inscite Illinois (DBA FIRST Illinois Robotics) assists FIRST in this program. The majority of the revenue within Inscite Illinois related to FIRST Robotics Competition was local fund raising and expense payments to FIRST to cover a portion of running the Midwest and Central Regional FIRST Robotics Competitions in Chicago and Peoria respectively. Approximatley 1500 students were involved on teams in Illinois
