The Organization directly administers multiple funds, including six endowment funds according to the federal and state requirements, and the National Standards for Community Foundations. The majority of the direct support for the Organization is received from the State of Iowa, currently for the benefit of Carroll County and Sac County. Of those funds, 25% are required to be placed in permanent endowments for the benefit of the citizens of Carroll County and Sac County. The remaining funds from the State are to be used for the public benefit of each county to enhance the cultural, educational, and recreational opportunities, as well as for the public health and safety of local communities and other community opportunities. The Organization will only provide grants to qualified projects meeting the charitable objectives to benefit community citizens and to governmental organizations or those recognized as eligible charitable organizations under 26 U.S.C. 501(c)(3) or those similarly qualified. During the current year the Organization awarded 45 grants for the following types of projects: shelter house expansion, daycare security and safety improvements, balance boards for city park, playground renovations, recreational trail work, specialized software, digitization of old newspapers, pickleball court, fitness center, bike racks, streetscaping, rehabbing baseball field, cemetery kiosk, zero entry pool, prepackaged food for food bank, handicap fields, mental health services for children, reshingle historical farmstead, therapeutic electric beds, climate control area for birds, field trips for children with special needs, park improvements, handicapped accessible restroom, improvements to public library, emergency shelter, athletic complex restroom, historical kiosks, street markers, shelter house improvements, furnace for historical society, cemetery connector trail, and park improvements.
