THE FLORIDA REGIONAL OFFICE IS IN CLEARWATER, FLORIDA, THE NORTH CAROLINA REGIONAL OFFICE IS IN FAYETTEVILLE, NORTH CAROLINA, AND THE DELAWARE REGIONAL OFFICE IS IN NEW CASTLE, DELAWARE.
