These funds were used to provide food, education, shelter, clothing, basic shared amenities, and necessary travel to support the monastic life of 160 monks and nuns residing at the monasteries that train in the practice of Engaged Buddhism in the tradition of Thich Nhat Hanh.

Through this process the Endowment is able to determine where the need is the greatest, and how its mission can be best fulfilled through grant-making. Additionally, the Endowment generally has written grant agreements with the grantees, keeps detailed records of receipts available upon request, and receives informal reports of how the funds are used.

Part II, Column D: In fulfilling the mission of the Endowment, funds were used to provide food, education, shelter, clothing, basic shared amenities, and necessary travel to support the monastic life of 160 monks and nuns residing at monasteries that train in the practice of Engaged Buddhism in the tradition of Thich Nhat Hanh. These monasteries are located in Thailand and Vietnam. Disbursements were made via wire transfer in May and June 2019.

Dr. Hussman is a current officer of the UBC Endowment and is indirectly engaged in a business of transaction with the UBC Endowment.

The UBC Endowment has taken a number of precautions to ensure that this transaction remains fair and does not violate the excess benefit transaction rules. First, and most important, all investors in the funds held by the Hussman Investment Trust and managed by Hussman Strategic Advisors, including the UBC Endowment, pay the same fees. The fees paid to Hussman Strategic Advisors are determined by the open market and on an arms' length basis. A considerable number of persons have chosen to pay these fees and confirm the fairness of the price. As of June 30, 2019, the two Hussman Funds that the UBC Endowment held investments in had over 8,400 shareholder accounts and combined assets of approximately \$515 million. Furthermore, the securities law requires the independent trustees of Hussman Investment Trust to review the fees annually and make a determination that the fees paid to the Adviser are reasonable.
