As part of See's Community Fund (SCF) mission, we have two ways we partner with local organizations: (1) We enlist the help of other non-profit organizations to help staff our fund raising store. Because it's hard to maintain volunteer staffing, SCF awards 5% of gross sales per shift to the organizations providing volunteers. The result is that we still maintain a small profit margin, after contributing to the partner non-profits, to still fund the local cancer patient's needs. (2) We reimburse medical providers who provide care to low income people for mammograms, ultrasounds, lymphedema equipment and occasionally other costs. (3) Grant Process for Individuals (only Humboldt & Del Norte County residents). We have an application form which screens cancer patients for the need for financial support, income eligibility (at or less than 200% of the Federal Poverty Level), and require proof of cancer diagnosis and upcoming medical appointments (or other special needs if in treatment). For low income women needing assistance with mammograms, we obtain requests for payment from the local hospitals doing mammography, who have screened the individuals for income eligibility and insurance status.
