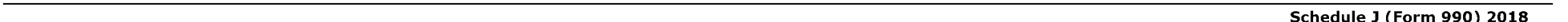

Accredited by the Joint Commission, Bonnie Brae is one of the nation's preeminent therapeutic learning environments for at-risk New Jersey boys, ages 8-21, who have histories of trauma and are struggling with mental health issues, resulting in behavioral challenges. We provide the opportunity for them to discover, develop and maximize the skills necessary for them to become responsible young men. Bonnie Brae serves approximately 225 boys each year who hail from almost every county in the state of New Jersey. Most of them have been referred by the Department of Children and Families and arrive at Bonnie Brae after an average of 5.6 out-of-home placements, including juvenile shelters and foster homes. We regularly take on some of the most challenging young men referred by the State of New Jersey. Many of these boys have suffered abuse, trauma or neglect and often have had addiction issues and/or gang involvement. Having endured these traumas, the boys have very demanding emotional and behavioral needs. We break these cycles by helping them develop skills, experience positive relationships, and prepare for independent living. Additionally, we provide comprehensive family therapy for those young men who are returning to their families. Of Bonnie Brae's entire population approximately 34% are African American, 30% are Caucasian, 30% Latino, 5% Biracial, and 1% Asian. When boys arrive at Bonnie Brae 74 PERCENT have had multiple school suspensions, 68 PERCENT have been abused, neglected or witnessed violence inside or outside the home, and 52 PERCENT are on psychotropic medications. Despite this, after 12-18 months at Bonnie Brae, 100 PERCENT of all eligible students graduate from our program. Bonnie Brae defines successful discharge as being discharged to a less restrictive setting which captures our ability to help these boys stop their downward spiral. Of alumni surveyed that were discharged between July 2015 through December 2016 87 PERCENT were enrolled in high school or graduated, 58 PERCENT were working, 49 PERCENT have had no contact with the Justice System, 47 PERCENT were living in the community, and 10 PERCENT were enrolled in post-secondary education (community college, university, or trade school). Bonnie Brae's successful track record is based on a foundation of richly experienced professionals including Child Care Workers, Clinicians, Nurses, Child Psychiatrists, Pediatricians, Support Staff, Substance Abuse Counselors, and Teachers. Treatment is primarily based on forming positive relationships between traumatized children and caring, knowledgeable staff.
