The Anchor House Shelter provides safe shelter and crisis intervention services for abused, runaway and homeless youth ages 13 to 17. Residential services include shelter, food, clothing, medical and mental health care. Residents and out clients received individual, family and group counseling, life skills education, educational preparation, job readiness skills, substance abuse prevention and counseling, transportation, recreation, and service linkages. Aftercare counseling and support groups are available to residents, at-risk community youth and their families. A total of 54 youth resided in the shelter this fiscal year with an average stay of 14 days. Most youth, 61% were from Mercer County, and 46% of the youth were from the City of Trenton. The School Outreach Program provided individual and group counseling to shelter residents, as well as students in six schools in Mercer County.

Form 990, Part III, Line 4b:

The Anchorage Transitional Living Program provides shelter, food, clothing, medical attention, psychological evaluations, therapy, individual and group counseling, life skills training, employment and educational services to homeless youth ages 18-21 to ensure their successful transition to independence. This year nine youth resided in the program, and all completed educational goals of completing their high school education, and/or pursuing or attending college and vocational programs. The average stay was seven months and 78% of youth secured employment. Discharged youth transitioned into safe, permanent housing. Staff help youth secure other resources such as wraparound funds for furniture and other necessities, and scholarships for college. An additional eight youth returned for aftercare services.

Form 990, Part III, Line 4c:

Building Lasting Connections provides intervention strategies, including coaching and mentoring to youth currently in the child welfare system who are at a greater risk of becoming homeless. Youth in the Connect to Home program are aging out of the child welfare system or may have been previously involved in the system and have experienced homelessness. Connect to Home provided supportive services and apartments through Housing Choice Vouchers for Section 8 Housing to 20 youth.

Anchor Line Transitional Apartment Program provides apartments for homeless youth, 18 through 21 years of age. Youth receive life skills training, employment and education assistance, medical and mental health access and therapeutic counseling. Youth are taught how to advocate for themselves, access supportive services, and obtain and retain employment. This year nine youth resided at Anchor Line and attended college or vocational programs and 78% obtained employment.

Anchor Link Outreach includes our CoC (Continuum of Care) Rapid Rehousing Program, Coordinated Entry for Homeless Youth, and the Youth Advisory Council. Rapid Rehousing serves youth 18 to 24 years of age who are HUD eligible for supportive housing. The program provides rental assistance, case management, employment and educational assistance, life skills training and assistance with housing counseling and searches. A total of 17 youth were served this fiscal year. Coordinated Entry for Homeless Youth worked with an additional 32 youth. Our Youth Advisory Council (YAC) continues to be involved in the Mercer County Safe Rest Youth Engagement Committee and now attend the Capital City Youth Violence Coalition meetings. One of our young women was chosen to be on the National Network for Youth's National Youth Advisory Council and participated on a panel at the NSPN's Youth Conference. Youth also attended the Homeless Youth Hill Day in Washington D.C. and met with local and national politicians to advocate for increased resources for homeless youth.
