COLUMBUS HOUSE STAFF PROVIDE STREET OUTREACH IN NEW HAVEN AND MIDDLETOWN TO WORK WITH PEOPLE WHO DO NOT OR CANNOT COME INTO THE SHELTERS IN THOSE COMMUNITIES.
