STATEMENT 1

THE ORGANIZATION IS FILING THIS RETURN TO REQUEST A REFUND FOR ESTIMATED TAX PAYMENTS MADE FOR THE ADDBACK OF EMPLOYEE FRINGE COMMUTING BENEFITS UNDER SECTION 512 (A)(7) OF THE INTERNAL REVENUE CODE.

THE "FURTHER CONSOLIDATED APPROPRIATIONS ACT OF 2020, SIGNED INTO LAW ON DECEMBER 20, 2019 EFFECTIVELY STRIKES SECTION 512 (A)(7) FROM THE INTERNAL REVENUE CODE, WHICH DISALLOWED DEDUCTIONS FOR EMPLOYERS WHO PROVIDE COMMUTING FRINGE BENEFITS FOR EMPLOYEES.

AS A RESULT OF THE NEW LEGISLATION, THE ORGANIZATION IS REQUESTING A REFUND FOR ESTIMATED TAX PAYMENTS MADE.
