Please consider this penalty abatement request from the Somerset Hills Education Foundation (the Foundation) regarding the late filing for the Form 990 Tax Period June 30, 2019.

Facts and Circumstances

The Somerset Hills Education Foundation was founded in 1996 and received its IRS determination letter recognizing its tax-exempt status effective 06/12/1996. The Foundation operates on a fiscal year ending on June 30th.

The Somerset Hills Education Foundation's mission is to promote educational opportunities through innovative programs and projects. The Foundation fulfills its mission by attracting financial and in-kind gifts of goods and services and allocating them for the benefit of the students of The Somerset Hills School District.

The Somerset Hills Education Foundation is a small, all-volunteer organization. The Foundation does not have paid financial managers. The position of treasurer is filled by a part-time volunteer. The Foundation has no reason, motive, or intent not to comply with all filing requirements of which it is aware.

Circumstances Resulting in the Discovery of Non-compliance

An extension for the 2019 Form 990 was filed on a timely basis. However, during the time surrounding the new filing deadline of the 2019 Form 990, we were in the peak of the COVID-19 pandemic in New Jersey and there was a death of a close family member due to COVID-19 of the person responsible for filing the Form 990. The ball was dropped and the Foundation inadvertently missed the May 15, 2020 filing deadline.

By preparing and filing the delinquent Form 990 as quickly as possible after discovering its delinquency, and before receiving penalty notices, the Foundation believes that its demonstrated that it is acting in good faith and is not exhibiting “willful neglect.”

- Please consider that no taxes were due with the Form 990, and there was no injury to any party involved due to the late filing. The Somerset Hills Education Foundation, Inc. is a small, all-volunteer charity organization. The Foundation strives to promote educational opportunities through innovative programs and projects. The Foundation fulfills its mission by attracting financial and in-kind gifts of goods and services and allocating them for the benefit of the students of The Somerset Hills School District. Having to pay penalties and interest would cause extreme financial hardship for the Foundation that already runs on a tight budget, and would create a significant reduction in educational programs and projects.

Absence of Willful Neglect

We believe that the Foundation’s long history of compliance with the Form 990 filing requirement is strong evidence against any assertion of willful neglect. Based on the facts and circumstances presented herein, it is clear that there was no intentional violation of a known legal duty; therefore, willful neglect could not have been a factor contributing to the delinquency.

Request for Abatement of Penalties

Based on the foregoing facts and circumstances, we are appealing to the sense of fairness and purpose as set forth in IRS Policy Statement 20-1 regarding penalty and interest assessments.

IRS Policy Statement 20-1, as presented in the Internal Revenue Manual section 1.2.20.1.1, paragraph 1 states that "Penalties are used to enhance voluntary compliance."

The filing of a late Form 990 by a normally on-time and fully compliant taxpayer or his agent does not in any way endanger or undercut voluntary compliance. Thus, punishing an error resulting from an isolated occurrence of an unintentional oversight does not appear to be in line with IRS Policy Statement 20-1.

Based on the evidence we have presented regarding the existence of significant mitigating factors with respect to the failures, and that the Foundation acted responsibly and without willful neglect with respect to its filing obligations, and that the Foundation has put policies and procedures in place that will prevent future delinquencies, we respectfully request that the IRS abate the assessed daily delinquency penalties and interest under the reasonable cause provisions of IRC section 6652.
