WellSpan-Good Samaritan Hospital maintains its support of Lebanon County's safety net of services that enables access to care among vulnerable populations through: enrolling financially-challenged community members in Healthy Community Network, a partnership between WellSpan Health, physicians and community partners to support prospective enrollment, the management and support of patients, and coordination of care; supporting the expansion of a diabetes support group offered by Lebanon Valley Volunteers in Medicine to meet the needs of the growing, Spanish-speaking population in Lebanon, and; the ongoing partnership between Lebanon Family Health Services and WellSpan Good Samaritan Hospital to utilize doctors from the hospital's Family Medicine Residency program to provide prenatal care for its low-income clients. Additionally, WellSpan Good Samaritan Hospital leadership selected Family First Health, a federally qualified health center with locations throughout central Pennsylvania, to provide primary care services at the WellSpan Dixon Foundation Health Center. The WellSpan Dixon Foundation Health Center will open in 2020 and will improve access to primary care, behavioral health and other health and social services in Lebanon County. WellSpan-Good Samaritan Hospital is an integral partner in the Community Health Council of Lebanon County and, as such, supports key Council initiatives such as the Lebanon County Tobacco Coalition, Lebanon County Teen Pregnancy and Support Network, and Lebanon County Suicide Task Force. WellSpan-Good Samaritan Hospital maintains its support of the full-time, Executive Director position by leveraging Community Partnership Grant funds to cover this expense. Additionally, the Council maintains alignment with Better Together in Lebanon County and launched a mobile kitchen to provide hands-on cooking classes to residents, in partnership with The American Heart Association. Additional efforts focused on: an email and social medical platform to connect residents to local health and wellness events and services; educational initiatives that emphasize importance of advanced care planning and end of life care, and; tackling the issue of homelessness by supporting the Lebanon County Coalition to End Homelessness. Additional Community Partnership Grant funds were provided throughout Lebanon County to support a multitude of health-related initiatives including support for occupational and rehabilitation programs for blind and visually impaired patients who are underinsured, and the Lebanon Public Library system by providing support for coordinated summer programs that improve school readiness and increase physical activity in children and teens. Beginning with the 2015 CHNA, WellSpan-Good Samaritan Hospital transitioned to a streamlined approach to regional CHNA processes in an effort to bring consistency to the entire footprint of WellSpan Health. The 2018 CHNA is a compilation of primary and secondary data sources including telephonic interviews, a review of the Robert Wood Johnson Foundation County Health Rankings, and an analysis of access, behavioral risk and health condition indicators from the PA Department of Health's data retrieval system. Information collected through the CHNA was shared with key community stakeholders to gain their input and perspective on the data, to learn about the existing healthcare environment in Lebanon County, and to identify priorities on which three-year implementation strategies should focus. These stakeholders represented the Lebanon Family Health Services, Lebanon Valley Family YMCA, and the United Way of Lebanon County. A subsequent presentation and discussion of the data and identified priorities was held with the Community Health Council of Lebanon County Board, a coalition of diverse individuals and organizations working together to encourage and support a safe, healthy and substance-free community for every Lebanon County resident. Sectors represented in the Council included, for example: aging population; behavioral health; community-based organizations; education; healthcare; county government; faith-based organizations; drug and alcohol resources, and; philanthropy.

In 2018, CHNA results and related priorities identified by WellSpan Health and the Community Health Council of Lebanon County were shared with the system-wide Planning Committee at WellSpan Health. This committee is comprised of community members and leaders that represent each of WellSpans primary entities and service areas, in addition to corporate leadership. Collaboratively, the Community Health Council of Lebanon County and WellSpan community health leadership communicated the CHNA results and identified priorities to community members at a public forum held in September 2018. During that forum, CHNA data, CHNA priorities/ opportunities, and WellSpan and coalition recommendations were presented and discussed.
