THE FINAL DECISION BELONGS TO THE CHAIR OF THE BOARD, UNLESS THE POTENTIAL CONFLICT INVOLVES THAT PERSON, THEN IT GOES TO THE HEAD OF THE SCHOOL IN CONSULTATION WITH THE EXECUTIVE COMMITTEE OF THE BOARD. IF A CONFLICT IS IDENTIFIED, A DETERMINATION IS MADE ABOUT THE POTENTIAL FOR SUCH A CONFLICT TO COMPROMISE THE SCHOOL'S WELL-BEING WHICH INVOLVES QUESTIONS OF MAGNITUDE (USUALLY FINANCIAL), CONSEQUENCES, ALTERNATIVES, ETC. THE WELL-BEING OF THE SCHOOL, ITS STUDENTS/FAMILIES, ITS FACULTY/STAFF, AND ITS OVERALL COMMUNITY IS ALWAYS THE PRIMARY BASIS FOR A DECISION AS TO WHETHER OR NOT THE SCHOOL CAN PROCEED DESPITE THE CONFLICT. ANNUAL DISCLOSURE OF ACTUAL AND POTENTIAL CONFLICTS IS REQUIRED.
