PHYSICIANS, EDUCATORS, RESEARCH EXPERTS AND COMMUNITY MEMBERS SERVE ON THE IRB. IN 2015 THE WRIGHT CENTER FOR GRADUATE MEDICAL EDUCATION (WCGME) WAS AWARDED A SCHOOL-BASED HEALTH CENTER (SBHC) CAPITAL DEVELOPMENT GRANT THROUGH THE HEALTH RESOURCES AND SERVICES ADMINISTRATION (HRSA). 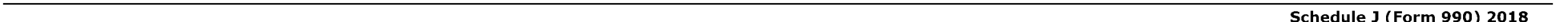
