We provide three fully staged, professional productions each season at our home theater, Emilie K Asplundh Concert Hall, on the campus of West Chester University. (See schedule O)

Fall 2018 Brandywine, Barber & Balanchine - a repertoire, semi professional ballet - 3 performances

This mixed repertoire production featured a selection of varied works, by a handful of different choreographers. We opened the show with George Balanchine's iconic ballet, "Serenade" and the performances of this Balanchine(c) Ballet were presented in arrangement with the George Balanchine Trust and was approved in accordance with Balanchine Style (c) and Balanchine Technique (c) Service standards. The ballet is set to Tchaikovsky's Serenade for Strings in C, Op. 48 and is an insiders look into the dynamics of the dance studio and Balanchine's unique method of creating a new ballet. Also featured on the program was a work by Brandywine Ballet Resident Choreographer, Nancy Page, titled "Voices" - this work features the famous Adagio for Strings by West Chester Composer Samuel Barber, and is an exploration of the light and dark within each of us. Two works by Meredith Rainey were also on the program- "Birdland" was set on Brandywine Ballet Theatre dancers, and "PMG" was set on Brandywine Ballet Company. Tim Early's work "Tooth & Nail" was set on Brandywine Contemporary dancers.

Tchaikovsky's timeless score and our captivating choreography transport viewers alongside Clara and her Uncle Drosselmeyer on a the magical journey of a dream. The quality of this ballet and its lavish sets and costumes allow Brandywine Ballet to present a high-caliber production in downtown West Chester, making this holiday classic accessible to the regional community.

Spring 2019 - Cinderella - a full length, semi professional ballet - 4 performances

Brandywine Ballet proudly presented our premiere of Nancy Page's "Cinderella" in May of 2019. This classic fairytale is told beautifully through the art of ballet. The Stepsisters & Stepmother have made Cinderella a servant in her own home, and they laugh at the prospect of Cinderella joining them at the Royal Ball. Cinderella is left behind and a beggar woman appears seeking shelter. Cinderella is kind to the beggar woman and invites her in and offers her food and warmth, and the beggar woman reveals herself to be Cinderella's Fairy Godmother. She creates a whimsical garden world to entertain Cinderella before sending her off to the Ball. At the Ball Cinderella has a wonderful time and falls in love with Prince Charming, and forgetting that she must leave by Midnight, when the magic disappears. In her haste she leaves behind a magic slipper, and the Prince makes an oath to find his love - the woman whose foot fits the slipper.
