Mercy Hospital Foundation ("The Foundation") provided \$825,710 in funding in fiscal year 2019 to Mercy Hospital Iowa City for several large facility improvement projects, medical equipment, patient comfort items, educational materials and programs, nursing and health career scholarships, assistance with Advance Directives and more to improve patient care, enhance the hospital's healing environment and provide support for specific areas such as Mercy Hospice Care, Mercy Behavioral Health Care, Diabetes Education, Cancer Care Services, Nursing Units, Surgery and much more (Schedule O) Donor support was directed primarily to areas of greatest need but also to specific purposes such as the new Mercy Infusion Center This is a space within the hospital that allowed Mercy Medical Oncology to move into the hospital, now occupying a completely remodeled space, and is now a dedicated location for any patient receiving infusion therapies for any reason The Center is open 7 days a week for the convenience of its patients and these new, expanded hours are a huge improvement to patient care The Foundation paid for all of the expenses (\$616,607) associated with this new facility, making it a huge and vital project The Foundation also made more than \$197,000 of improvements to the Mercy Behavioral Health Unit, making it safer and more efficient for patients and colleagues The Foundation also made it possible to remodel and outfit two treatment rooms in the Emergency Care Department to be safe for patients in a mental health crisis The Foundation contributed \$86,104 to renovate areas of Mercy Guest Lodging, an area with 15 modest guest rooms with private baths, where families of patients can stay for a fee of \$35 per night to be close to their loved ones This is of particular convenience considering the geographic reach of Mercy Iowa City's largely rural service areas Mercy's scholarship program provided 34 Health Career Scholarships of \$1,000 each to students graduating from high school in Mercy's 10-county service area who plan to major in a health career in college, and 44 Nursing Scholarships to employees who are continuing their advanced nursing education The Foundation continues to provide all of the educational materials used with the roughly 450 patients in the Diabetes Education program and provided \$5,000 in funding for a pilot discharge planning and follow up care program that has proven very successful Another program provides assistance to women who cannot afford diagnostic testing for breast cancer including mammograms, ultrasound and more, using gifts donated specifically for this purpose The medical and other equipment supported by the Foundation serves a general population of this hospital Educational programs, materials and patient comfort items are directed by hospital staff to the appropriate patients including clothing and blankets, toys for pediatric patients, support items for Cancer patients, therapeutic musician services for patients in the mental/behavioral health unit, art to invigorate patient and visitor areas, and much more
