UFM Community Learning Center is a creative educational program serving Kansas State University, the Manhattan, KS area, and the state of Kansas. UFM provides opportunities for lifelong learning and idea exchange. UFM also serves as a catalyst and host for new programs and services that enhance the quality of life for all.

UFM Education Program: This is UFM's largest program and primary mission activity. The education program offers a wide variety of noncredit and credit courses and workshops. In FY19, UFM offered 818 noncredit courses and 209 courses were offered for credit through Kansas State University. 3,516 (unduplicated count) persons took noncredit courses and another 1,504 received KSU credit. Class topics include aquatics, arts and hobbies, foods and nutrition, earth and nature, health, and fitness and recreation. UFM is the sole Licensed Training Provider for the American Red Cross in Manhattan, KS and is the largest provider in Kansas. UFM collaborates with many other organizations to serve the community and participates in community awareness activities. UFM hosts the Osher Lifelong Learning Institute classes in collaboration with the University of Kansas and K-State Global Campus. This year we had 546 enrollments in classes offered in FY19. UFM hosted swimming classes for USD#383's Summer Fun Camp and hosted Talk20MHK. These brought over 300 combined participants. UFM serves as the host for noncampus groups using the KSU Ahearn Complex. Almost 3,000 people attended events in FY19.

4b (Code:) (Expenses \$ 124,213 including grants of \$) (Revenue \$ 124,261)
Manhattan Area Risk Prevention Coalition (MARPC): UFM receives and administers funds on behalf of MARPC, a coalition of 12 community sector representative organizations and individuals. The organization's focus is risk reduction and prevention among youth, especially in the area of drug/alcohol use issues and prevention activities. A new focus that began in FY19 is vaping among youth. In FY19, MARPC received year three of a federal Drug Free Communities grant. Funding was used for a media campaign on social hosting, responsible alcohol use and not providing alcohol to minors. MARPC began an effort to engage youth by designing a contest for youth to develop media messages dispelling myths of alcohol, vaping and marijuana use. This project is continuing to be developed in FY20. MARPC coordinated Sticker Shock in Manhattan and Ft. Riley. This project involved about 60 volunteers placing stickers, focused on not providing alcohol to minors, on packaged alcohol products in liquor stores. MARPC also participated in public events, sharing information with parents. 1,491 participated in MARPC events. MARPC also received \$305 in contributions from the community.

UFM Teen Mentoring Program: The Teen Mentoring Program offers a structured program of support and life skills to youth in grades 7 - 12. Project goals for the teens include learning positive life skills and focusing on primary prevention and intervention activities. Students from Kansas State University serve as mentors. Participant referrals come from the schools, community corrections, parents, and teen participants who sometimes bring their friends. This program is funded by the City of Manhattan Special Alcohol Fund. In FY19, the program offered three after school groups each week. 58 youth were served and 50 K-State students served as mentors.

Part III. 4d. 1. Manhattan Community Garden. Expenses: \$15,702 Grants: \$0 Revenue: \$21,011

Low cost garden plots are available for Manhattan and Riley County residents. Electronic newsletters are produced three times a year and an electronic gardening hints newsletter is sent weekly during the gardening season. Power tools, hoses, hand tools, and some seeds are provided as well. Land for the gardens is leased from the City of Manhattan and Riley County. In FY19, 188 families gardened 280 plots. Revenue appears to be high because plot signups overlap two fiscal years with much of the revenue for the following year collected in the current year. Excess funds are used for garden maintenance, equipment replacements, and reserved for future garden development.

Part III 4d. 2. Manhattan Nonviolence Initiative Expenses: \$17,227 Grants: \$0 Revenue: \$28,335

This is a short project initially funded in FY17. The focus of the program is to make and maintain a safe and equitable campus and community through the practice of everyday nonviolence. Activities included creating community conversations, local gatherings, and participating in collaborative meetings with others interested in civil discourse on community issues. Specific activities included the Harmony in the 'Hatt music festival, Empty Bowls to support food insecurity, Kindness Rocks, teaching Peaceful Communication classes and promoting the Season for Nonviolence. Participation was 1,158.

Part III 3d. 3. Project EXCELL (Extending College Education for Lifelong Learning) Expenses: \$14,330 Grants: \$0 Revenue: \$16,650

Project EXCELL provides area adults with mild developmental/intellectual disabilities enrichment classes in a college-like setting. Traditional college students serve as mentors and classroom aides. Classes are held on Saturday mornings during the fall and spring semesters on the K-State campus. In FY19, 76 students were enrolled and over 100 KSU students assisted.

Part III. 3d. 4. Lou Douglas Lecture series. Expenses: \$8,163 Grants: \$0 Revenue: \$2,370

This lecture series brings speakers to the Kansas State University campus. The theme of the series is social justice, human rights, and world peace. In addition to the evening lecture, speakers often visit K-State classes, meet with students and participate in campus and community events. In FY19, speakers included Carolyn DeWitt addressing voting rights and Kevin Willmott, a writer on the film BlackkkKlansman, speaking about his experience with the film. Over 700 attended the lectures.

UFM Short Projects is an account used to support contributions to UFM facility projects and small community projects. UFM serves as the screener for local tennis scholarships. This year, a study was contracted to evaluate facility updates in the UFM Solar addition.
